New Business: Referral of Ordinance from Mayor and Council/Resolution approval Revision of an ordinance amending section 22-10 revised the general ordinance of the Borough of Victory Gardens about pet shops. Jim Glass said it is in reference to puppy mills. The attorney explained the process. Barrie explained this was introduced and comes to the Planning Board for comments. Barrie said in paragraph three it allows for the animal rescue organizations to sell their animals. So, if the board does not want any animals sold, then we need to change it to read that. Jim Glass asked about the doggie daycare holding adoption days. Do we want to allow that? He is not sure about what wording to place into the ordinance to read that this is not allowed. Barrie asked the planner if he had any thoughts or suggestions? He asked for clarification that the board does not want any selling of any animals. Jim Glass said or adopt them and Barrie clarified that the selling of animal items, food, bedding, treats, etc. should still be allowed. The attorney said the board should do a resolution for the council recommending the changes they see fit. They agreed that there should be no organization or entity selling of any animal sales and they should prohibit adoption and or rescue within the Borough limits. The change should read "no entity shall sell", not no pet store. The whole second sentence should come out. And number three should come out. This should refer to all animals. Barrie has asked that the attorney rewrite the resolution and then it will be discussed at the next meeting and then presented to the Council.
