Kevin Lewthwaite made the motion open the meeting to the public. Mayor Dave Holeman seconded it. All in were in favor.

Valerie Williams asked Manuel Venero and Harry Bami how much experience they had with Land Use procedures? Mayor Dave Holeman informed her that the question is of individual information and she cannot ask individual's questions, she must address her questions to the entire Board. She then asked what Professionals were appointed with regards to the Resolution 2021-01? Mayor Dave Holeman stated what was on the Resolution: Legal representation – Eric Bernstein, ESQ from Eric Bernstein & Associates, LLC. Engineer – Leon Hall, PE from Anderson & Denzler Associates, Inc. Planner – Jessica Caldwell from J. Caldwell & Associates, LLC.

Valerie then asked if the Board was going to vote on how long a member of the public can speak and or ask questions. It was stated it will remain the same as in the past, five (5) minutes. If there were extenuating circumstances then it may be possible that the time would be extended. That extension of time will have to be voted upon by the Board. She asked who will be transcribing the minutes, Debbie Devery will be. Valerie asked if the Board oversaw the construction department, Kevin answered, no it does not oversee the construction department. She went on to say that she had a meeting with Kevin before the meeting regarding the stairs in front of her home. He stated that the steps are built into the Borough right of way. If someone were to take them out and rebuild them, they could not rebuild them into the Borough right of way. Kevin corrected something that Valerie had said about the right of way. He stated it is determined by the road width and other factors, this Board nor Zoning does not determine the right of way. There was some discussion in which two people were talking at the same time and difficult to decipher. She went on to discuss her situation with her stairs and Kevin tried to explain the right of way again. Kevin explained, he has read the file with regards to her steps but he cannot make any determination until he further investigates. He also stated the Board cannot speak about this until an application regarding this has been made and he is unaware of one at this time.

She asked him to tell her that no application, after all these years, has been made? He said he cannot speak of that and he would not speak of it. He did say as a Zoning Official, not being on the Planning Board, as the Zoning Official he would try and work with her to resolve the issue. Valerie then asked Kevin what classification he was. Kevin said he was a Class 2.
