

April 22, 2025

Regular meeting of the Mayor and Council of the Borough of Victory Gardens, held on April 22, 2025.

Mayor Holeman called the meeting to order and declared a quorum present.

Pledge of Allegiance to the Flag of Our Country.
Please remain standing for a moment of silence for our military.

This meeting has been advertised in one newspaper, The Daily Record, in compliance with the New Jersey Open Public Meeting Act.

ATTENDANCE: Councilman Suarez, Councilman Glass, Councilwoman Hedgepath, Councilman Hale, Councilwoman Garcia Montes.

ABSENT: Councilman Lorenzo.

Motion to accept the minutes of 4/8/25 as received by Councilman Glass, seconded by Councilwoman Montes and approved on verbal vote. None opposed.

CORRESPONDENCE:

CONDOS - We are getting calls about overcrowding in the condos. One complaint stated that there were 5 people living in a one bedroom. The other complaint was that there were 8 people living in a one bedroom apartment.

Council said this is a condo problem. The Clerk said that she will send a letter to the Condo Association if I can find who that person is.

DOVER SUPERINTENDENT - I received an email from the Dover Superintendent of Schools. He wants to have a meeting over here at Borough Hall for our residents that have children going to Dover schools. They want to have a casual forum to share school updates and then have conversations with parents. He's asking for May 20th. The Clerk said if they want to open the building for them who will be here to let them in and to lock up when they leave?

Councilwoman Hedgepath said the parents can go to any school board meeting they want to. You don't have to have a special meeting for that.

Council said no on the meeting in Victory Gardens. The Clerk said she would let the Superintendent know.

LETTER OF RESIGNATION FROM CHRIS BARELLA/FIRE OFFICIAL - Chris is resigning his position with the Borough. His wife is having health issues and Chris needs to take care of her.

I have been calling around to try to find someone to replace him. Not many people out there looking for this type of work. I did get a name from Bob Young who is our Fire Subcode inspector.

The name I got was Bernie Grillette. He works part time in Florham Park which is how he knows Bob. He is willing to do the job for what Chris was getting paid and he can start May 1 which is Chris' retirement date.

Administration Committee would like to speak with him and asked the Clerk to see if he can meet April 28th after work. I will call him tomorrow.

MULCH AT PLAYGROUND - We have spoken about this before. We need to put mulch up there. I have 2 proposals. One is for the regular mulch at a cost of \$1,192.80. The other one is for the rubber mulch at a cost of \$6,450.00.

Council said to go with the regular mulch. All approved.


WHEREAS, the Assessor will hold public office hours on Wednesdays from 1:00 p.m. to 2:00 p.m.

OLD BUSINESS: None


Motion to open the meeting to the public by Councilwoman Montes, seconded by Councilman Glass and approved on verbal vote. None opposed.

Jim Janone - When State Police issue tickets they don't get the money. They get it for State. Any local tickets they don't get anything. For the electronic signs there are companies that do municipal signs. They will come out and they will tell you what is best for you. There are regulations on the mulch for playgrounds. The Board of Education meeting is an outreach program. Yes, that is what I said. Who is doing the mulch? The place where we got the quotes is from Ben Shaffer Recreation. For the overcrowding at the condos, they aren't going to do anything about it. All they are worried about is getting their condo fees. They regulate their own rules. They don't care about the Borough codes. The Clerk said she spoke to the Council several times about hiring a part time Housing Officer and they haven't done it yet. Margaritas Bar & Grill I mentioned this at the last meeting. I checked our Zoning ordinance and under permitted uses. There is nothing permitted for night clubs, dancing, What restaurant is open past midnight. I see this is going to be a problem in the summer. We redo their liquor license in June. Right now we have a hold on their hours of operation. When it comes time to redo the license if Council wants to change their hours they can do that. If they choose to leave hours as they are currently, then those stipulations will be special conditions of their liquor license.
