** At this time the meeting was turned over to the CFO and the Auditor.

Jason said this is the introduction to the budget. The overall tax levy will be 3.45%. On the average home that means a \$39.00 increase for 2025 for the year. That includes a 2% increase in salaries. The biggest increases that we are seeing are the RVRSA and the health benefits. RVRSA was the biggest increase. Overall, we are pretty flat in the rest of the budget. We have no control over the two biggest items.

Councilwoman Montes said she would like to see no increase in the

budget for next year. Jason said if we could get there he would be happy to do that. I never make those kind of promises.

The Mayor asked if there were any questions from the Council regarding the budget? Hearing none, he asked for a motion to introduce the budget.

Councilman Suarez asked if we can do somewhere else that looks worse than Roosevelt? Yes, but it has to be done quickly so Leon can get the grant application in.

Councilman Lorenzo said Cleveland Avenue is bad and also the section of Polk Avneue from Washington to Roosevelt. The Clerk said she will give the information to Leon and have him go take a look at it and whichever one is worse we will have him apply for that. Council agreed.

Jim Janone - Glad to hear you got the list of the kids. Will this be given to you quarterly or yearly? We don't know. Councilwoman Montes said have the property maintenance guy go to the houses. It is not his job. He is not allowed in anyones house unless they invite him in. Jim Janone said he doesn't think it will cost that much to have someone do the job. Did anyone see what the new school budget is? No. They said ouur rateables went up \$154,000. I don't know where they got that numberfrom. Dovers ratables went up \$93,000. According to their budget, Dover is going to have a 19% increase and Victory Gardens will have a 22% increase which comes out to about \$300.00 more.I saw something on linethat Dover is spending reserve money to do an addition. Has anyone heard that? Councilman Suarez said he saw a picture. It was for the 6th grade. They aren't putting it out for a vote so I guess they are using money that they have in reserves. I saw numbers for about \$700,000. And this is for a school? An addition. They bought Dover Sport Center for pre K. I can't see how this can affect us or if it will. If they need more than the initial money they are putting out and they bond it then that will affect us and we have to have a say so in what they do. The Attorney said they would have to put it up for a vote. This is apparently a done deal. Their budget is going up about 3 million dollars for next year. Our reval will take place for next year? Yes. Are we factoring in anything in our budget for the website for next year? Not in this budget. I did ask the CFO if we are able to use any money from the american Rescue Plan to do some stuff for us and I haven't heard back from him. I willask him. Can we use it for our budget? I don't know. I will have to check with the CFO.

Motion to close the meeting to the public by Councilman Glass, seconded by Councilwoman Hedgepath and approved on verbal vote. None opposed.

Councilwoman Montes asked if know anymore about what is going on with the school monies. The attorney said he was speaking with the CFO beforethe meeting and he said there seems to be a discrepancyin what I believed we were suppose to have and what the numbers actually show. There is a difference of about \$400,000. That will hold us up a little more.
